

COOKIES POLICY

This website (the “**Site**”) uses its own- and third-party cookies. Please read this Cookies Policy to learn more about what cookies are, which cookies do we use, for what purposes and how can you disable them.

Through the configuration of Cookies, or the acceptance of the Cookies notice, you are consenting to the installation of cookies informed or configured (unless you have modified the configuration of your browser to reject all or certain cookies by default).

1. What are cookies?

Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site. Cookies are not viruses - they are plain text items and are not compiled code - so they cannot be executed on, or affect the operation of, the device.

Some cookies are temporary, like the “session cookies” and remain on the user's machine until they close the website. They do not remain on the user's computer. Some others are persistent, this means that stay stored in a computer's cookies file after the user has closed the website. They will re-connect to the web page when it is next opened, remembering information that facilitates navigation (direct access to the service without needing to repeat the login process) or providing a commercial service (offering products or services related to previous visits).

Cookies can be created by the website being visited (they are called “own cookies”) and some will be received by the site owner from third parties (they are called “third-party cookies”) when navigating a website generated by a third-party service hosted by that website. For example, a cookie used by an advert or advertising banner on the website visited.

The purposes of the cookies may differ as follows:

Technical cookies

Technical cookies are those that allow the user to navigate through the website or application and the use of different options or services that exist therein. For example, control traffic and data communication, identify the session, access restricted access, remember elements regarding an order, make the application for registration or participation in an event, use security elements during the browsing and storing contents for the dissemination of videos or sound.

Customization cookies

Are those that allow the user to access the service with some general characteristics predefined in their device or that the user defines him/herself. For example, the language, the type of browser through which you access the service, the selected content design, geolocation of the device and the regional configuration from where the service.

Advertising cookies

Are those that allow the effective management of advertising spaces that have been included in the website or application from which the service is provided. They allow to adapt the content of the advertising so that it is relevant for the user and to avoid showing ads that the user has already seen.

Analytical cookies

Are those that allow tracking and analysis of the behavior of users on websites. The information collected through this type of cookies is used in the measurement of the activity of the websites, application or platform and for the elaboration of navigation profiles of the users of said sites, with the purpose of introducing improvements in the service based on of the usage data that users make.

2. What type of cookies uses this Site?

This Site uses the following cookies. Moreover, we inform you that the use of third-party cookies may involve data transfers outside the European Economic Area. List of essential and functional cookies

axeptio_cookies	12 months	Axeptio. Contains all information about the visitor's consent, such as the date, their unique anonymous ID, and whether or not they have already consented.
axeptio_all_vendors	12 months	Axeptio. Contains the list of all cookies declared in the Axeptio widget.
axeptio_authorized_vendors	12 months	Axeptio. Contains the list of cookies accepted by the visitor.

List of analytical cookies

_ga	13 months	Google Analytics. Distinguish unique users by assigning a randomly generated number as a customer ID.
_gat	1 minute	Google Analytics. Reduce the number of requests
_gid	24 hours	Google Analytics. Store and update a unique value for each page visited.

3. How to uninstall cookies?

At any time, you will have the possibility to accept or reject the installation of cookies or reject the installation of a certain type of cookies, such as the analytical cookies. Also, after each session you can delete all or some of the stored cookies.

When visiting our Site for the first time we will offer you the possibility to configure which Cookies you wish to install. You can oppose the installation of any category of Cookies by means of the Cookies Preference Center herein ("change your consent"), except for the technical ones which are necessary for the proper functioning of the Site by selecting your options. Likewise, you may at any time reject the installation of a certain type of cookies, by configuring the browser itself. Moreover, you can accept, reject, or modify your preferences regarding the use of cookies in the Cookies Preference Center accessible via the icon located at the bottom left of the website.

Please note that if at any time you delete the cookies from your browser, it is possible that your opt-out preferences will be eliminated.

Also, you can activate:

- private browsing, through which your browser stops saving browsing history, website passwords, cookies and other information of the pages you visit, or

- the function of not tracking, by which the browser asks the websites that you visit not to track your browsing habits, for example, to serve you with advertising of your interest in the sites you visit.

We recommend that you consult the help of your browser to learn about the different options on how to manage cookies. Keep in mind that the blocking of cookies can affect all or some of the features of our Site. For your convenience, below we provide the help links from different browsers:
